*As per Baltimore City Public Schools, all kindergarten applicants must be 5 years of age by September 1, 2019. Parents whose children turn 5 between September 2<sup>nd</sup> and September 15<sup>th</sup> of the school year may request early admission to kindergarten by completing an *Early Admission Request Packet* (which can be picked up at the school's main office). Early entrance into Kindergarten is intended for children with exceptional ability who are capable of working in a classroom setting with children who are at least one year older. A lottery will be conducted for all out of zone applicants if more applications are received than seats available. Non-city residents will only be offered seats after all Baltimore city residents are served.*
